Enclosed is one copy of MECA's Tariff M.P.S.C. No. 25(U) revisions being filed under Tariff Transmittal 248 under the authority of Public Acts 179 of 1991, 216 of 1995, 295 of 2000, 235 of 2005, and 52 of 2008.

This filing is being made pursuant to its rate-setting authority and the inapplicability of MTA Section 310, as specified in Section 310(7) and its exemption from Section 310(2).

This thereby removes these following parts from MECA's Tariff M.P.S.C.
